1. Application and Conclusion of Contract Applications to exhibit at this exhibition must be made on the official printed Application Form, which must be accurately completed and signed in legally effective manner Such an application constitutes a contractual offer to the organiser. By signing this form, the General Conditions for Participation in the Exhibition are recognised as binding by the applicant, who is also responsible and liable for adherence to the said conditions.

Admission and Stand Space Confirmation

Admission of exhibitors and isled exhibits is a matter for the sole discretion of the organiser, who will confirm same in a written stand space confirmation. The contract comes into force by admission. Reservations or conditions stiputated in the septications are invalid without the written confirmation by the organizer. For materially lustifiable reasons, especially should the written confirmation by the organizer may secure individuals or suppliers from exhibitors and or restrict the event to specific groups of exhibitors or suppliers from executing the sum and purpose of the event The organizer is also entitled to restrict the listed origin the sum and purpose of the event The organizer is also entitled to restrict the size of the school of the exhibitors pace for which application has been made. - The exhibitor violates the site regulations. The organizer reserves in such cases the right to claim for demange.

16. Removal of sublists or dismantling of stands before the end of the fair or exhibition is not permitted.

17. Page proved of the organiser is needed if any stand construction exceeds the specified height limits for stands.

12. Force Majeure

If the exhibitor is prevented from participating in the event for reasons for which
naffishe he not the organises is responsible (force majeure), the stand rental shall be reduced
by half in accordance with the terms of Clause 6. If the organizer is prevented by
force majeure from holding the event, he is required to notify the exhibitors accordingly
whiteut delay. Basically, the claim to stand rental is voiced, but the organiser may charge the
exhibitor for works carried out following his orders to the extent of the costs incurred. Should
the organizer be in a position to hold the event at a last educ or another verue, he is likewise
required to notify the exhibitor to this effect without delay. The exhibitor is
entitled to cancel his participation in the event of a new time or venue within one
week of receiving such notification. If the organizer is compeled to curtail or cancel an event
for reasons of force majeure after it has commenced, the exhibitor has no claim to any refund
or cancellation of the stand rental.

### 13. Exhibitor Passes

13. Extinutor P35SES. A limited number of exhibitor passes will be issued to exhibitors and their employees for the period of the fair or exhibition. These passes will be made out in the name of the persons concerned. They are not transferable and only valid in conjunction with an identity card. 
